- eligibility: A dance couple must consist of a male and a female partner. All wheelchair users must have a minimum disability. Standing dancers must be able to perform as an able-bodied dancer. Couples from foreign countries must be announced by the National Paralympic Committees.
- Rules: The events Combi Standard and Latin in the Classes 1 and 2 and Duo Standard and Latin in the Classes 1 and 2 will run under the IPC Wheelchair Dance Sport rules and regulations

- time limit: A minimum of one and a half minutes for Waltz, Tango, Slow Foxtrot and Quickstep, and a minimum of one minute for Viennese Waltz.
 A minimum of one and a half minutes for Samba, Cha cha cha, Rumba and Paso Doble and a minimum of one minute for Jive.
- area of dance : 15 x 20 m²
- procedure: Couples are dancing in two classes: Lwd 1 and Lwd 2 (see competition rules)
- International Classification: International Classification process is pending due to the final entries list. Conformation for International Classification will be offered after review of the final entries. The classification panel will be appointed by IPC Wheelchair Dance Sport. The athletes who will be classified will need to bring with them the IPC WDS Medical information form in English
- doping: Doping is forbidden in accordance with the IPC Anti-Doping Code. (With the registration the competitors recognise these rules).
- judging: A dance couple is judged by at least 7 adjudicators, according to the judging criteria (see competition rules). The adjudicators will be informed in advance to give couples a lower mark when they cannot see proper feet and ankles through the length of the dress.
- Results: Only results from athletes who have been licensed by IPC WDS (including partners) will be taken in consideration for inclusion in the results and ranking list of the events Combi Standard and Latin in Classes 1 and 2 and Duo Standard and Latin in Classes 1 and 2.
- Ranking: The minimum number of participating countries per event must be 3 for Combi Standard and Latin in Classes 1 and 2 and Duo Standard and Latin in Classes 1 and 2. In the case lower number than 3 the couples can participate but no ranking points will be considered for the IPC WDS World Ranking List.
- entry: Please use the enclosed entry form. The forms should be sent to the Organising

Committee by fax or mail no later than the **1st of March 2012**.

To be valid the entry forms must be signed by the President or General Secretary of the National Paralympic Committee and or responsible person in Wheelchair Dance Sport.

accommodation & transport: **See enclosed information paper for a special Holland Dans Spektakel arrangement.**

competition fee: € 10,00 per person per day (only when it is booked in advance), transport and accommodation NOT included.
